Glentinar Community Football Club – Fee’s Structure

The Glentinar fee structure is split into 12 equal monthly payments

There are currently two different payment structures. Typically, the younger players have lower running costs to the Club and this is reflected in the fee structure. Players participating in Soccer 4’s and 5’s will pay reduced membership with those participating in 7, 9 and 11 a-side formats paying the full Club fees.

The preferred method of payment is by monthly direct debit. Although players will typically only play and train for 9 months in any year, the monthly payments are set-up to roll-forward automatically. This is done to reduce administration in stopping and re-starting the monthly payments at the end of the season as most players continue with the Club for several years.

An alternative payment option of paying via the club collaboration app ‘Spond’ is available for those not wishing to pay direct debit. However, this payment will be subject to a 10% administrative fee.

Note: If once the treasurer has reconciled all payments from the previous month a payment has not been received from an individual then a payment request with the 10% fee will be sent via Spond.

If a player leaves the Club, any overpayments of fees are refunded after return of all Glentinar supplied kit.

If any player has financial difficulties, fees may be reduced in part or in full at the discretion of the Committee. This will be treated in the strictest confidence.
